THE COURT CONSIDERED ALL REQUIRED FACTORS OF THE LAW.

THE COURT FINDS THAT A COMMUNITY CONTROL SANCTION WILL ADEQUATELY PROTECT THE PUBLIC AND
WILL NOT DEMEAN THE SERIOUSNESS OF THE OFFENSE. IT IS THEREFORE ORDERED THAT THE DEFENDANT IS
SENTENCED TO ONE YEAR OF COMMUNITY CONTROL ON EACH COUNT, UNDER THE SUPERVISION OF THE
ADULT PROBATION DEPARTMENT WITH THE FOLLOWING CONDITIONS:

- 1.) DEFENDANT TO ABIDE BY ALL RULES AND REGULATIONS OF THE PROBATION DEPARTMENT.

- 3.) REPORT EVERY 6 MONTHS
- 4.) DEFENDANT IS ORDERED TO PAY A MONTHLY SUPERVISION FEE OF \$20.00.
- 5.) DEFENDANT IS ELIGIBLE FOR EARLY TERMINATION REQUEST WHEN ALL CONDITIONS HAVE BEEN MET.
- 6.) CONDITIONS AND TERMS OF PROBATION ARE SUBJECT TO MODIFICATION BY THE PROBATION OFFICER
AND APPROVAL OF THE COURT.

VIOLATION OF THE TERMS AND CONDITIONS MAY RESULT IN MORE RESTRICTIVE SANCTIONS, OR A PRISON
TERM OF 1 YEAR(S) AS APPROVED BY LAW.

THIS SENTENCE APPLIES TO EACH OF THE COUNTS: 35, 47, 61.

DEFENDANT MUST WITHIN 24 HOURS PLACE HIMSELF ON INACTIVE STATUS WITH THE OHIO SUPREME COURT'S
ATTORNEY REGISTRATION SYSTEM AND REMAIN ON INACTIVE STATUS WHILE ON COMMUNITY CONTROL
SANCTIONS.

THE PARTIES AGREE COUNT 61 CARRIES 7 YEAR PROHIBITION FROM PUBLIC OFFICE ETC.

THE COURT HEREBY ENTERS JUDGMENT AGAINST THE DEFENDANT IN AN AMOUNT EQUAL TO THE COSTS OF
