Dear Mr. Bunstine:

On August 28, 2013, in Case No. 2012-2049, the court suspended you from the practice of law for a period of one year with six months stayed on the condition that you commit no further misconduct. In addition, on September 16, 2015, in Case No. 2014-1392, the court suspended you from the practice of law for a period of six months with no credit for the time served in Case No. 2012-2049. On March 22, 2016, you filed applications for reinstatement in each of your disciplinary cases. The Supreme Court of Ohio has informed the clerk's office that it will not consider an application for reinstatement until the attorney has complied with the court's orders and the Rules for the Government of the Bar of Ohio.

The suspension orders in the above-referenced cases state:

It is further ordered that respondent shall not be reinstated to the practice of law in Ohio until (1) respondent complies with the requirements for reinstatement set forth in the Supreme Court Rules for the Government of the Bar of Ohio, (2) respondent complies with the Supreme Court Rules for the Government of the Bar of Ohio, (3) respondent complies with this and all other orders of the court, and (4) this court orders respondent reinstated.

On March 13, 2012, in Case No. 2011-0647, the court suspended you from the practice of law for a period of six months with the entire suspension stayed on the condition that you commit no further disciplinary violations. The court further ordered that you bear the costs of publication of the order in that case. On December 18, 2012, an invoice for publication costs in the amount of \$184.70 was issued. The publication costs and interest

due on those costs remain unpaid. The total amount currently due is \$240.90. Payment must be made by cashier's check or money order.
