
## Journal Entry

This order is being issued in compliance with the mandate of the Ohio Supreme Court in State ex rel Odolecki v. Celebrezze, Ohio Supreme Court Case No. 2016-0436. This court has been directed to consider appellant's request for bond on an expedited basis. This court previously denied appellant's request for bond after considering the following: motion to set bond and brief in opposition filed on February 26, 2016, reply in support of motion for bond filed on February 29, 2016, and appellant's supplemental brief in support of motion to set bond filed on March 9, 2016. The motion was denied on March 10, 2016. Appellee filed a supplemental brief in opposition on March 10, 2016. Appellee filed a supplement brief opposing the request for bond on May 6, 2016 and appellant filed a response on May 9, 2016.

The court has reconsidered all of the previously filed motions and briefs, as well as appellee's supplemental brief in opposition that was filed on March 10, 2016 and May 6, 2016 and appellant's response filed on May 9, 2016. Upon reconsideration of appellant's request for bond as directed by the Ohio Supreme Court, appellant's motion for bond is granted effective upon the posting of Ten Thousand Dollars (\$10,000.00), cash or surety.
