

Now come the Common Pleas Court of Mercer County, Ohio, Probate Division, the Honorable Mary Pat Zitter, a Judge of the Court of Common Pleas, and the Honorable James Rapp, a Judge by Assignment of the Court of Common Pleas (the "Respondents"), and request leave of Court to Supplement Respondents' Motion for Reconsideration filed this same date.


On June 1, 2016, this Court issued an order granting a Peremptory Writ of Prohibition prohibiting Respondents "from exercising jurisdiction . . . consistent with the opinion to follow." On June 13, 2016, Respondents filed a Motion for Reconsideration. However, as of the time of filing the Motion for Reconsideration, this Court has not issued its opinion, and Respondents are unable to formulate arguments for reconsideration specific to the basis of the majority opinion of this Court.

For the foregoing reasons, Respondents request leave of this Court to file any supplemental arguments in support of reconsideration within ten (10) days from the filing of the opinion of this Court.




