claims under Kentucky law. These alleged judgment creditors involve decedent and bankruptcy estates. A certified copy of the docket in case A-1602508 is attached as Exhibit D. It demonstrates that Relators filed the following:

May 13, 2016 – Defendants Reply to Motion for Injunctive Relief

May 16, 2016 - Response to Plaintiffs Motion For Injunction to Prevent Enforcement of Improperly Domesticated Judgment.

June 1, 2016 – Defendants Motion to Dismiss Pursuant to Civil R 12B (1) and (6) and Request for Attorney Fees.

June 1, 2016 – Defendants Motion to Transfer and Perminantly Assign case to Judge Cooper

June 20, 2016 – Supplement to Defendants Response to Chesley’s Motion for Injunctive Relief to Prevent Enforcement of Improperly Domesticated Kentucky Judgment

The docket indicates that the case was rolled to Judge Ruehlman on May 4, 2016. The case is currently set for a hearing on Motions on June 22, 2016 at 11:00 a.m.

B. Argument

It appears that the real issue presented by Relators is not a jurisdictional dispute at all. They are more than willing to have Judge Martin or Judge Cooper hear the Hamilton County Court of Common Pleas case A-1602508. Instead, this is an effort to remove Judge Ruehlman.

The proper remedy for removal of Judge Ruehlman is an affidavit of Bias and Prejudice.

The Ohio Constitution Article 4, Section 5(C) provides:

(C) The chief justice of the supreme court or any judge of that court designated by him shall pass upon the disqualification of any judge of the courts of appeals or courts of common pleas or division thereof. Rules may be adopted to provide for the hearing of disqualification matters involving judges of courts established by law.

The procedure for filing an affidavit of Bias and Prejudice with the Chief Justice is set out in R.C 2701.03. If Relators have a specific complaint about Judge Ruehlman, other than the

anticipation that he might not rule in their favor, they should follow the proper procedures to obtain relief.

This Court's Entry of September 17, 2015 in this case only addressed Court of Common Pleas case number A-1500067. Judge Ruehlman is not violating that prior Entry. Additionally, the new Court of Common Pleas case may actually involve an issue which is different from case A-1500067. The current case appears to discuss the ownership of the Kentucky Judgment more than its validity.

For a Writ of Prohibition to issue, this court must find that the Respondent patently and unambiguously lacks jurisdiction. *State ex rel Tubbs Jones vs. Suster*, 84 Ohio St.3d 70, 701 N.E.2d 1002 (1998). "There are various scenarios in which a court might have jurisdiction over an issue that provides the court with the opportunity to declare the judgment of any other court to be void." *Lingo v. State*, 2014-Ohio-1052, 7 N.E.3d 1188, ¶ 47. If the wrong person or entity is attempting to domesticate a foreign judgment, that should be an issue for a court of common pleas to examine.

Relators, if Judge Cooper was making the determination, would not be in this Court requesting an emergency stay.

CONCLUSION

The Emergency stay should be denied.


IN MANDAMUS AND PROHIBITION


It is further ordered that respondent may file a revised response to the complaint in accordance with the time permitted in S.Ct.Prac.R. 12.04.


