Mr. Gonzales submits the following portion of ¶15 of *State v. Sanchez*, which was released after oral argument in this case:

According to the laboratory reports which were admitted as exhibits at trial, the lab determined the net weight of the crack cocaine purchased on July 1, 2008, to be 34.1 grams, 42 percent of which was actual cocaine. The actual amount of crack cocaine was 14.3 grams. The powder cocaine purchased on July 1, 2008, had a net weight of 4.3 grams, 78 .3 percent of which was actual cocaine. The actual amount of powder cocaine was 3.3 grams. And the crack cocaine purchased on August 14, 2008, had a net weight of 6.8 grams, 70.9 percent of which was actual cocaine. The actual amount of crack cocaine was 4.8 grams.

State v. Sanchez (6th Dist. No. S-14-030, February 12, 2016), ---N.E.3d---, 2016 WL 618068, 2016 -Ohio- 542, appeal allowed by *State v. Sanchez*, Ohio, June 15, 2016.
