The State of Ohio submits *State v. Sanchez*, including the complete ¶ 15, which was released by the Sixth District Court of Appeals three days after the oral argument in this case.

**An analysis of the substances was performed by the DEA's North Central Laboratory in Chicago, Illinois.**

According to the laboratory reports which were admitted as exhibits at trial, the lab determined the net weight of the crack cocaine purchased on July 1, 2008, to be 34.1 grams, 42 percent of which was actual cocaine. The actual amount of crack cocaine was 14.3 grams. The powder cocaine purchased on July 1, 2008, had a net weight of 4.3 grams, 78.3 percent of which was actual cocaine. The actual amount of powder cocaine was 3.3 grams. And the crack cocaine purchased on August 14, 2008, had a net weight of 6.8 grams, 70.9 percent of which was actual cocaine. The actual amount of crack cocaine was 4.8 grams.

*State v. Sanchez*, 6<sup>th</sup> Dist. Sandusky No. S-14-030, 2016-Ohio-542, ¶ 15, appeal accepted and cause held for decision in 2015-0384, *State v. Gonzales*, and briefing schedule stayed, 2016-Ohio-3390. (Bold to indicate omission from paragraph in similar filing by Appellee.)
