

1. I immediately ceased practicing law upon receiving the Court's June 14, 2016 Suspension Order;
2. I have not entered into any employment, contractual, or consulting relationship with any attorney or law firm but am aware of the registration requirements of Gov. Bar R. V(23)(C);
3. I have paid the costs of these proceedings in the amount of \$974.00, **(Exhibit A)**;
4. No funds were awarded against me by the Lawyer's Fund for Client protection so there is no amount to reimburse within 90 days;
5. I notified all clients being represented in pending matters and any co-counsel of my disqualification to act as an attorney after the effective date of the June 14, 2016 Order;
