

Raymond L. Eichenberger, being first duly sworn and cautioned deposes and says that:


1. He has an address of 7544 Slate Ridge Blvd., Reynoldsburg, Ohio 43068 and has personal knowledge of the facts referred to herein.
2. In regard to his compliance with the Decision and Order of this Court suspending his license to practice law for two (2) years on June 20, 2016, he replies as follows.
3. He was never served with Notice of the Decision and Entry of this Court by this Court's Clerk either by certified mail or regular mail to the date of this Affidavit.



4. As a result, the procedures and Orders of this Court were never properly explained to him or proper notice given to him as of the date of this Affidavit.
5. He is not currently in possession of his current attorney registration card in order to surrender it to the Court, and the card has either been lost or misplaced. In over thirty-five years of practicing law, or since the procedure of issuing the cards to attorneys was begun, he cannot recall using the card for any purpose.
6. To the best of his ability, all clients of his office with which he has pending matters have been notified of his suspension from the practice of law, and steps have been taken by him to attempt to assist those clients to find substitute legal counsel for any pending court cases..
7. He did not realize until reviewing the requirements after his receipt of the Show Cause Order of this Court that said notification had to be by certified mail.
8. He will immediately take steps to again notify the current and pending clients of his office of his suspension by certified mail in order to meet the requirements of the Court, and will file a supplemental Affidavit with this Court when certified mail receipts have been returned from the post office.
