### MOTION AND PROCEDURAL RULINGS

**2001-1403. State v. LaSalle.**

Summit App. No. 20488. This cause is pending before the court on the certification of conflict by the Court of Appeals for Summit County. Upon consideration of the joint motion for amicus curiae, Attorney General of Ohio, to participate and present oral argument scheduled for May 22, 2002, on behalf of appellant,

IT IS ORDERED by the court that the motion for amicus curiae, Attorney General of Ohio, to participate in oral argument be, and hereby is, granted, and amicus curiae may present oral argument on behalf of appellant.

## **ADMINISTRATIVE ACTIONS**

On February 26, 27, and 28, 2002, the Ohio Bar Examination was administered in Columbus. On May 10, 2002, results of that examination were released. Out of 493 applicants, 258 applicants (52.3%) received passing scores; out of 230 first time applicants, 67% received passing scores. The names, cities, and counties of the successful applicants appear on the attached list.

The oath of office will be administered to applicants who were successful on the examination and who have satisfied all of the Supreme Court's other requirements for admission. The oath will be administered during a special public session of the Supreme Court which will be held at The Ohio Theatre, 39 East State Street, in Columbus, on Monday, May 20, 2002, at 2:00 P.M.
