#### THE OHIO SPECIALIZED DOCKETS PRACTITIONER NETWORK

With over 100 specialized dockets in operation throughout Ohio, the Supreme Court of Ohio, the Ohio Department of Alcohol and Drug Addiction Services and the Ohio Department of Mental Health have recognized the need for interaction among the professionals that staff these courts. In order to provide such a forum, the Ohio Specialized Docket Practitioner Network was created to provide peer support and technical assistance to these programs. # MILESTONE OF 3,000 CRISIS OFFICERS TRAINED IN OHIO RECOGNIZED AT SUPREME COURT

"We need to encourage everyone to recognize the real successes of CIT," said Justice Stratton, who chairs the committee. "Every time a person in crisis receives appropriate treatment in the community, there is progress. Every time a first responder intervenes with a person in crisis and the officer safely completes their shift, there is progress." More...

#### NEW NAME, WIDER MISSION FOR BENCHMARK

New name, same purpose. At a ceremony Thursday the Erie County Benchmark Program transitioned into the new Intervention Court, which will encompass both drug and alcohol abuse treatment programs and mental health treatment. The last two Benchmark graduates received certificates for completing the 16-month program which addresses substance abuse issues. In addition, the graduates will have their criminal charges cleared for continual compliance with the program's standards. More...

#### SOME POLICE OFFICERS DROP "TOUGH GUY" APPROACH TO HELP MENTALLY ILL

Ohio has trained more than 3,000 police officers how to deal with people who have mental health problems. Andrew Savada of the Streetsboro Police says THESE days, when he encounters a criminal suspect or troublemaker with symptoms of mental illness, he drops the "tough-guy" approach he used to use all the time. Instead, Savada says he uses the approach he learned in crisis intervention training. Police say this new approach has two advantage: it gets treatment for citizens who need it, and it helps keep police officers from being injured or killed. More...

# PEPPER-SPRAY BURNS BLAMED FOR JAIL DEATH

An array of autopsy photos in the case of Summit County Jail inmate Mark D. McCullaugh Jr. showed his windpipe was so badly burned from inhaling streams of pepper spray that it "clearly resulted in respiratory impairment" and, ultimately, led to his death, a medical examiner's official said Monday. **More...** 

#### MAN FATALLY SHOT BY DAYTON OFFICER WAS RELEASED FROM TWIN VALLEY

The man shot to death by a rookie Dayton police officer on Saturday night, July 19, had a history of drug problems and mental illness, and was released from Twin Valley Behavioral Healthcare as the state mental hospital was preparing to close because of state budget cuts, his family said Sunday. #### MAN STRUGGLED FOR YEARS BEFORE BEING SHOT TO DEATH BY OFFICER

In the photograph, a young Ricky Moore is beaming as he stands beside his bride on their wedding day. But the years that followed clouded the picture, his family said. Moore was shot and wounded in street violence years ago, an aunt said. He got involved with illegal drugs and was estranged from his wife. He was diagnosed with schizophrenia and drifted in and out of the state mental hospital and prison. More...

# **JUVENILE COURT RECEIVES \$188,000 GRANT**

When it comes to stemming juvenile crime, success obviously begets success. The Allen County Juvenile Court will receive a \$188,000 grant this year though the Ohio Department of Youth Services. This is the first year the county has received the grant, a fact Judge Glenn Derryberry attributes to local collaborations that have reduced the number of youth returning to detention facilities. ### TREATMENT TOUGH TO REQUIRE FOR MENTAL ILLNESS

Officials say the police shooting of an Ohio man whose family says he was mentally ill highlights a dilemma: Forcing residents into treatment is almost impossible until it's too late. Police shot and killed 55-year-old Rick Sarver last weekend in suburban Middleburg Heights. Sarver was a frequent caller to police dispatchers, telling them about his sightings of Jesus, Mary and Joseph walking down the road, police said. More...

#### 16,000 OHIOANS STUCK ON MEDICAID PAPERWORK BACKLOG

Administrative processes take months — sometimes years — to navigate, leaving in-need residents frustrated or suffering. More...

Toledo Mayor Carty Finkbeiner yesterday continued his battle with Toledo Municipal Court over its funding, casting a tie-breaking vote in City Council to deny a request for drug-testing money. In a letter written Monday, Mr. Finkbeiner claimed Judge Timothy Kuhlman and the court's other judges want to be held to an "untouchable standard" of funding while other city departments cut back. #### ALTERNATIVE COURTS GAIN GROUND FOR PETTY CRIMINALS

Cities and counties increasingly are creating innovative community courts to deal with the growing number of habitual petty criminals that police call "frequent fliers." Criminals who are arrested repeatedly for crimes such as public drunkenness, trespassing and panhandling are crowding jails and sapping police resources, officials say. The cost of handling small-time criminals who cycle in and out of jail is becoming a more pressing problem for communities as budgets tighten and jail populations swell. More...

### MANHATTAN PROGRAM ENCOURAGES PAROLEES TO STAY OUT OF PRISON

Critics of the parole system say one reason parolees end up going back to prison is because they don't get enough support when they get out of jail. #### FEDERAL REPORT FEATURES CHILDREN'S WELL BEING

The <u>Federal Interagency Forum on Child and Family Statistics</u> has released "<u>America's Children in Brief: Key National Indicators of Well-Being, 2008.</u>" The Office of Juvenile Justice and Delinquency Prevention is one of the <u>22 Federal agencies</u> that constitute the Forum.

Each year since 1997, the Forum has published this report, which includes detailed information on the welfare of children and families, alternating between a comprehensive report and a condensed version that highlights selected indicators, as is the case this year.

The report addresses such topics as family and social environment, economic circumstances, health care, physical environment and safety, behavior, education, and health.
