#### MILLIONS SPENT ON AILING, AGING INMATES

Lawrence Reynolds overdosed on pills March 7. The Ohio State Penitentiary inmate was rushed to a Youngstown hospital. After nine days and thousands of dollars' worth of care, he was taken to Lucasville – and executed. You paid for the whole process, from his 24-hour surveillance when he took the pills to his hospital stay to his lethal injection. While the circumstances were unique, the fact Reynolds received extensive health care behind bars was not. More...

#### TEENS IN ABUSIVE RELATIONSHIPS GET PROTECTION UNDER NEW LAW

Teenagers who are victims of dating violence soon will have a tool to protect themselves from their underage abusers.

They will be able to get an order of protection against a boyfriend or girlfriend who harms them physically or threatens them with phone calls, texts or e-mails, as a result of a state law that goes into effect Aug. 15. More...

#### MENTALLY ILL INMATES REFUSE POST-PRISON HELP

State records show more mentally ill Ohio inmates are refusing help making the transition from prison. The increase comes even as prisoner advocates are suing Ohio to force the state to do more for mentally ill offenders leaving prison. A review of state mental health records by The Associated Press found nearly one in four mentally ill inmates last year either declined post-release services or never showed up to a pre-release appointment to talk about the services. #### FUNDING

#### FY 2010 JUSTICE AND MENTAL HEALTH COLLABORATION PROGRAM GRANTS

**DEADLINE:** April 8, 2010, at 8:00 p.m. Eastern Standard Time

The U.S. Bureau of Justice Assistance (BJA) has released its fiscal year 2010 solicitation for <u>Justice and Mental Health Collaboration Program (JMHCP)</u> grant applications. The program was authorized by the Mentally Ill Offender Treatment and Crime Reduction Act of 2004 (<u>MIOTCRA</u>) and promotes coordination among criminal justice, juvenile justice, mental health, and substance abuse agencies.

<u>Visit the BJA website to download the applicant eligibility requirements, instructions on registering for the online grant application system, and other application materials.</u>

Applicants should demonstrate a commitment to increasing public safety through innovative cross-system collaborations that improve responses to people with mental illnesses who come into contact with the criminal justice system. Eligible applicants are states, units of local government, American Indian tribes, and tribal organizations.

Three types of grants are available under this program:

- Planning (\$50,000 maximum award for 12 months)
- Planning and Implementation (\$250,000 maximum award for 30 months)
- Implementation and Expansion (\$200,000 maximum award for 24 months)

The Council of State Governments Justice Center, coordinator of the <a href="Criminal Justice/Mental Health Consensus Project">Consensus Project</a>, has provided technical assistance on behalf of BJA for the JMHCP since 2006. The Consensus Project website features information on the program and MIOTCRA, including <a href="snapshots">snapshots</a> of past grantees, <a href="frequently asked questions">frequently asked questions</a>, and a <a href="frequently to local to inform 2010">toolkit of resources</a> that can be used to inform 2010 applications.

#### VIOLENCE AGAINST WOMEN YOUTH SERVICES GRANTS

Deadline: April 22, 2010

The Office on Violence Against Women is announcing grants for direct counseling, advocacy, legal advocacy and mental health services for youth victims of sexual assault, domestic violence, dating violence and stalking; and for linguistically, culturally or community relevant services for underserved populations. Eligibility is limited to nonprofits, community-based organizations, and tribes and tribal organizations that provide services to teen and young adult victims affected by sexual assault, domestic violence and stalking. There will be \$4.8 million available for 50 grants.

#### DRUG FREE COMMUNITIES MENTORING

The White House Office of National Drug Control Policy (ONDCP) and the U.S Department of Health and Human Services (HHS) is announcing the availability of more than \$1.1 million for new Drug Free Communities Support Mentoring program (DFC Mentoring) grants. An estimated 15 new Mentoring grants will be awarded (up to \$75,000 per grant, per year) to drug and alcohol prevention community coalitions from across the nation. The length of the project period is up to two years. Eligibility is limited to community-based coalitions.

### FAMILY CENTERED SUBSTANCE ABUSE TREATMENT GRANTS FOR ADOLESCENTS AND THEIR FAMILIES

SUMMARY: The purpose of this program is to provide substance abuse services to adolescents and their families/primary caregivers in geographic areas with unmet need. Grantees will implement evidence-based practices, specifically the Adolescent Community Reinforcement Approach (A-CRA) coupled with Assertive Continuing Care (ACC), that are context specific focusing on the interaction between youth and their environments, family centered and community-based.

ELIGIBILITY: domestic public and private nonprofit entities

AWARD: 35 for up to \$300,000 each

#### OJJDP FY 2010 SECOND CHANCE ACT JUVENILE MENTORING INITIATIVE

SUMMARY: The Second Chance Act (P.L. 110-199) authorizes grants to government agencies and nonprofit groups to provide employment assistance, substance abuse treatment, housing, family programming, mentoring, victims' support, and other services to help adult and juvenile ex-offenders make a successful transition from incarceration to the community. In support of this goal, OJJDP will provide grants to support mentoring and other transitional services essential to reintegrating juvenile offenders into their communities. The grants will be used to mentor juvenile offenders during confinement, through transition back to the community, and post-release; to provide transitional services to assist them in their reintegration into the community; and to support training in offender and victims issues. Targeted youth must be younger than 18 years old.

ELIGIBILITY: State, county, and city governments, public and state controlled institutions of higher education, private nonprofit organizations and others

#### **FAMILIES AND DRUG COURTS**

#### METAMPHETAMINE USERS SERVICED BY DRUG COURTS

Deadline: April 29, 2010

On March 9, 2010, SAMHSA/CSAT announced a new grant program entitled "Grants to Expand Services to Children Affected by Methamphetamine in Families Served by Family Treatment Drug

Court." The purpose of this programis toexpand and/or enhance services to children (0-17 years) and families of those suffering from methamphetamine use and abuse, which have resulted in a referral/involvement in a Family Treatment Drug Court. The program will focus primarily on the children (0-17 years) of parents who use or abuse methamphetamine. It is expected that approximately \$4.4 million per year will be available to fund up to 12 grants. Awardees are eligible for up to \$370,000 per year for up to four years. The total program is expected to provide a total of nearly \$17.8 million over its four year course. Eligible applicants are existing individual Family Treatment Drug Courts.
