STATE JUSTICE SUPPORTS MENTAL HEALTH COURTS

Once known as the "Velvet Hammer" for her tough approach to criminal sentencing, Justice Evelyn Lundberg Stratton has since taken a somewhat different approach on the Ohio Supreme Court. Stratton, a Republican, was in Mansfield on Thursday to talk about what she described as a personal passion for the last 10 years – specialized courts for the mentally ill, who she said have been poorly served by the justice system. MOST OHIOANS SUPPORT MEDICAL MARIJUANA, POLLSTERS SAY, BUT STATE LAWMAKERS SHY AWAY

Ohioans of all races, income levels, educational backgrounds and ideologies tell pollsters that they support allowing Ohio doctors to prescribe marijuana to their patients. But Gov. Ted Strickland and most Ohio

lawmakers don't. So a medical marijuana bill introduced last week by Rep. Kenny Yuko and a handful of House Democrats has pretty much already gone up in smoke, despite what most Ohioans may think. More...

MEDICAL MARIJUANA DEBATE HEATS UP

Once again, the medical marijuana debate took center stage in Ohio on Wednesday. Mary Jane Borden strongly supports legalizing marijuana for medical use. She said her advocacy started when she heard four words. "Multiple congenital cartilaginous exostoses," said Borden. "It puts bumps at the end of your long bones, stretches your muscles, and it causes a lot of pain. These are all neurological issues in my case." More...

Legislation to legalize dispensing, growing and using marijuana for medical purposes has been introduced in the Ohio House. Passage is unlikely, but if that happens, Ohio would become the 15th state to make medical marijuana legal. More...

STOPPED CARS AT BRIDGE RAISE RED FLAGS

More than 40,000 cars and trucks a day cross the Jeremiah Morrow Bridge in Warren County, but it's not the passing vehicles that worry state troopers who patrol the area. Because it's Ohio's highest bridge, the structure in Turtlecreek Township attracts people considering ending their lives. About a half-dozen times a year, the State Highway Patrol is called to the 239-foot-high bridge on reports of people contemplating suicide, endangering troopers and motorists. More...

VIOLENCE AGAINST WOMEN YOUTH SERVICES GRANTS

Deadline: April 22, 2010

The Office on Violence Against Women is announcing grants for direct counseling, advocacy, legal advocacy and mental health services for youth victims of sexual assault, domestic violence, dating violence and stalking; and for linguistically, culturally or community relevant services for underserved populations. Eligibility is limited to nonprofits, community-based organizations, and tribes and tribal organizations that provide services to teen and young adult victims affected by sexual assault, domestic violence and stalking. There will be \$4.8 million available for 50 grants.

DRUG FREE COMMUNITIES MENTORING

Deadline: April 23, 2010

The White House Office of National Drug Control Policy (ONDCP) and the U.S Department of Health and Human Services (HHS) is announcing the availability of more than \$1.1 million for new Drug Free Communities Support Mentoring program (DFC Mentoring) grants. An estimated 15 new Mentoring grants will be awarded (up to \$75,000 per grant, per year) to drug and alcohol prevention community coalitions from across the nation. The length of the project period is up to two years. Eligibility is limited to community-based coalitions.

FAMILY CENTERED SUBSTANCE ABUSE TREATMENT GRANTS FOR ADOLESCENTS AND THEIR FAMILIES

SUMMARY: The purpose of this program is to provide substance abuse services to adolescents and their families/primary caregivers in geographic areas with unmet need. Grantees will implement evidence-based practices, specifically the Adolescent Community Reinforcement Approach (A-CRA) coupled with Assertive Continuing Care (ACC), that are context specific focusing on the interaction between youth and their environments, family centered and community-based.

OJJDP FY 2010 SECOND CHANCE ACT JUVENILE MENTORING INITIATIVE

SUMMARY: The Second Chance Act (P.L. 110-199) authorizes grants to government agencies and nonprofit groups to provide employment assistance, substance abuse treatment, housing, family programming, mentoring, victims' support, and other services to help adult and juvenile ex-offenders make a successful transition from incarceration to the community. In support of this goal, OJJDP will provide grants to support mentoring and other transitional services essential to reintegrating juvenile offenders into their communities. The grants will be used to mentor juvenile offenders during confinement, through transition back to the community, and post-release; to provide transitional services to assist them in their reintegration into the community; and to support training in offender and victims issues. Targeted youth must be younger than 18 years old.

ELIGIBILITY: State, county, and city governments, public and state controlled institutions of higher education, private nonprofit organizations and others

METAMPHETAMINE USERS SERVICED BY DRUG COURTS

Deadline: April 29, 2010

On March 9, 2010, SAMHSA/CSAT announced a new grant program entitled "Grants to Expand Services to Children Affected by Methamphetamine in Families Served by Family Treatment Drug Court." The purpose of this program is toexpand and/or enhance services to children (0-17 years) and families of those suffering from methamphetamine use and abuse, which have resulted in a referral/involvement in a Family Treatment Drug Court. The program will focus primarily on the children (0-17 years) of parents who use or abuse methamphetamine. It is expected that approximately \$4.4 million per year will be available to fund up to 12 grants. Awardees are eligible for up to \$370,000 per year for up to four years. The total program is expected to provide a total of nearly \$17.8 million over its four year course. Eligible applicants are existing individual Family Treatment Drug Courts.
