#### EDITORIAL: FLEXIBILITY NEEDED

A 2007 state law that requires school districts to do criminal background checks on applicants and current employees, and to fire or not hire those who have committed certain offenses considered 'non-rehabilitative,' is a reasonable effort to ensure Ohio students' safety, as long as school districts are allowed some discretion. A 2009 rule change gave districts some discretion by allowing them to retain or hire people with some otherwise-disqualifying convictions, if they happened far enough in the past. <u>More...</u>

## TOSSED RESULT WON'T STOP USE OF BREATH-ALCOHOL TEST

In October, a Madison County judge junked the results of an Intoxilyzer 8000 breath-alcohol test, the first time, apparently, that the controversial machine has failed a legal challenge in Ohio. But the results of the Madison County hearing don't appear to seriously threaten the slow rollout of Intoxilyzer 8000 machines. Madison County Municipal Judge R. David Picken moved to suppress the results of an Intoxilyzer 8000 test administered on a driver in West Jefferson because the officer who administered the test had not performed a required second test to verify the results of the first. #### SLAIN DAD HAD SAID SUSPECT WAS MENTALLY ILL, OFF MEDS

Just five months ago, William E. Liske, Jr., called the Ottawa County Sheriff's Office to report that his 24-year-old son had walked off after yelling at him and pushing him during a confrontation at his pole barn. Mr. Liske said he had brought his son home for a weekend visit from the Sandusky group home where he lived. He said William J. Liske was schizophrenic and apparently wasn't taking his medication. <u>More...</u>

## MARION COUNTY MAKING EFFORT TO UNDERSTAND, ADDRESS POVERTY

The initiative came from the book "Bridges Out of Poverty" and other guides. Marion Municipal Court Judge Teresa Ballinger and Magistrate Michele Worobeic attended education sessions hosted by the Ohio Supreme Court last year. They returned to Marion determined to apply the concepts to this community. They are supported by many factions of the community, including people from education, health and legal systems, local businesses, churches, aid agencies and public servants. More...

# 'AN ILLUSION OF TREATMENT'

Ohio's mental-health system, once a national model, is on the verge of collapse as the state careens toward the biggest budget crisis in memory.

Thousands have been slashed from the mental-health-care rolls. Others might have to wait months to see a psychiatrist. State funding for mental-health services has been decimated, Medicaid is gobbling up scarce local dollars, and hundreds of small group homes for the mentally ill have closed. <u>More...</u>

# AMERICAN FOUNDATION FOR SUICIDE PREVENTION TO FUND RESEARCH GRANT PROGRAMS

The American Foundation for Suicide Prevention (AFSP) will research grants to support studies that aim to increase understanding of the causes of suicide and factors related to suicide risk, or to test treatments and other interventions designed to prevent suicide. Investigators from all academic disciplines are eligible to apply, and both basic science and applied research projects will be considered. AFSP offers six types of research grants: 1) distinguished investigator grants of up to \$100,000 over two years; 2) standard research grants of up to \$75,000 over two years; 3) linked standard research grants for three or more sites of up to \$225,000 over two years; 4) young investigator grants of up to \$85,000 over two years; 5) postdoctoral research fellowships of up to \$100,000 over two years; and 6) pilot grants of up to \$30,000 over one or two years to provide seed

#### **REENTRY PROGRAM DIRECTOR**

Hamilton County, OH is seeking a reentry program director to coordinate the creation and execution of a public-private reentry strategic plan for the County. The plan will be a unified collection of shared goals and commitments by government, non-profit and faith-based agencies that will measurably improve the community reintegration of offenders returning from the criminal justice system. The program director will work with a task force to develop recommendations to eliminate or reduce barriers confronting offenders returning to their communities; identify gaps in reentry services and work with existing providers to develop remedies; collaborate with a wide range of stakeholders engaged in offender transition issues; and support the preparation of grant applications to secure funding to create and sustain evidence-based reentry initiatives. The position is grant-funded for one year with the potential for two renewal years. Qualifications: Bachelor's degree (master's preferred) in public administration, criminal justice or relevant area and five years managerial experience (or equivalent combination of training and/or experience); thorough knowledge of justice system operations; demonstrated ability to plan and implement programs and projects, persuade reluctant stakeholders, communicate effectively, and synthesize information to provide clear analysis and suggest concrete solutions.
