Howell and John Wilson. In doing so, the JJSIP provides a framework for improving juvenile justice practice throughout the entire juvenile justice continuum. **THE NEED:** A concussion is a brain injury. The CDC estimates 1.6-3.2 million concussions occur yearly in sports and other recreational activities. A concussion can happen in any sport, and it is important to quickly recognize and treat the injury. Unfortunately, this does not always occur, and athletes are at risk for complications. Because of the emerging data regarding the impact of head trauma on cognition and behavior, psychiatrists and other physicians have a need to expand their knowledge and skills at recognizing post-concussive changes. These changes may lead to neurodegenerative diseases such as dementia. Psychiatrists and other physicians need to be able to provide patients and consumers with input regarding concussion prevention as well. #### DRUG COURTS SAVE LIVES AND MONEY

More research has been published on the effects of Drug Courts than virtually all other criminal justice programs combined. By 2006, the scientific community concluded from advanced statistical procedures called *meta-analyses* that Drug Courts reduce crime and return financial benefits to taxpayers that are several times the initial investment. A large-scale study funded by the National Institute of Justice and completed in 2009 - called the Multi-Site Adult Drug Court Evaluation or MADCE - confirmed, once again, that Drug Courts reduce crime, reduce substance abuse, and reduce family conflicts associated with domestic violence and child abuse. # RECOVERY ACT INVESTMENT IN OHIOS WORKFORCE: USE AND DISTRIBUTION OF RECOVERY ACT AWARDS

Ohio received more than \$8.5 billion in Recovery Act funds more than \$370 million of which is dedicated funding to support job training. Only 45 percent of Ohio workers possess post-secondary credentials yet, more that half of all jobs will require post-secondary education. Recovery Act funds will help the state push back the skill gap and help individuals left jobless by the recession seek new employment and retrain for new careers.

This report, the first in a three-part series, presents a broad overview of the Recovery Act and investment in Ohios workforce development system from non-Department of Labor sources. These funds, which supported training programs in the health care, weatherization, and SmartGrid maintenance and implementation, were spent with high levels of public transparency, generated job growth, and helped workers train for jobs in growing industries and for better wages.
