COURT PROGRAM GIVES VETERAN SECOND CHANCE

Since April 2011, more than 50 veterans have participated in the Veterans Justice Outreach initiative, a partnership between the Middletown Municipal Court and Dayton Veterans Affairs Medical Center. And of the 56 veterans in the program, only three — or 5 percent — have failed to meet the court requirements, said Middletown Municipal Judge Mark W. Wall. More...

YOUNGSTOWN VETERANS TREATMENT COURT PROVING SUCCESSFUL IN SECOND YEAR

Coming back from the horrors of combat can leave a lasting impression on U.S. soldiers. That's why the Youngstown Municipal Court started the Veterans Treatment Court in January 2011 with the help of a \$35,000 state grant. The Veterans Treatment Court provides a second chance for troops who have mental or substance abuse problems and are charged with non-violent crimes. More...

WAR VETERAN COURT BEGINS OPERATIONS IN COLUMBUS

War veterans in Ohio's capital city will now have the opportunity to resolve legal issues in a special court. Judge Scott Vanderkarr is working with the Columbus City Council, Franklin County Commissioners, and several veterans' organizations to operate the court. The purpose of the court is to help keep war veterans out of jail, and provide them with counseling services, medical care, housing, and transportation. The court is designed to provide assistance to those who served in war – even for veterans who have not had a runin with the law. More...

COMMITMENT TO SETTING TARGETS, MEASURING RESULTS, AND CREATIVE COLLABORATION SETS CHATTANOOGA, TENNESSEE APART

Since the release of Chattanooga, Tennessee's <u>Blueprint to End Homelessness</u> in 2003, and the revamped Blueprint in 2007, the area has been able to make significant gains towards their homelessness goals—both in the number of people they have been able to help initially exit homelessness and the housing retention of those individuals. According to the June 2012 <u>Chattanooga Regional Homeless Coalition</u>'s <u>Blueprint Analysis</u>, 2,987 people have moved out of homelessness into housing since 2003, 90% of whom have remained housed. The period since the publishing of the 2007 Blueprint has been one of dramatic results, especially for the population in the Chattanooga region experiencing chronic homelessness. From 2007-2011, chronic homelessness declined by 89%, and overall homelessness declined by 48% according to Point In Time data. <u>More...</u>

NEW JUDICIAL COLLEGE ONLINE COURSE FOCUSES ON KIDS IN COURT

The Ohio Supreme Court Judicial College this week released a new free online course featuring original material and expert faculty from Ohio and Washington, D.C. The new course, called "Ensuring Meaningful Opportunities for Youth Engagement in Court," focuses on children's involvement in court during major permanency decisions including adoption, foster care or emancipation. It is open to judges and magistrates in all jurisdictions.
