This matter came before the Court on December 11, 2024, for hearing upon Plaintiff's Motion for Summary Judgment filed September 25, 2024. Plaintiff was represented by David T. Stevenson, Assistant Prosecuting Attorney. Defendant Jordan did not file a response to Plaintiff's Motion for Summary Judgment and did not appear for the hearing thereon. The Court, upon consideration of the Motion and the Affidavit filed in support thereof, finds the Motion to be well taken and grants Plaintiff's Motion for Summary Judgment.

Based upon the Court's finding, the Court further orders:

1. Defendant Terrell Jordan, also known as Tracy Halsell, is hereby declared a vexatious litigator under Section 2323.52 of the Ohio Revised Code; and
2. Defendant Terrell Jordan, also known as Tracy Halsell, is prohibited from doing any of the following without first obtaining leave of this Court to proceed:
  - a. Instituting legal proceedings in the Court of Claims or in a Court of Common Pleas, Municipal Court, or County Court;
  - b. Continuing any legal proceedings that he has instituted in the Court of Claims or in a Court of Common Pleas, Municipal Court, or County Court prior to the

entry of this order;

c. Making any application, other than an application for leave to proceed under R.C. 2323.52(F)(1) in any legal proceeding instituted by him or another person in the Court of Claims or in a Court of Common Pleas, Municipal Court, or County Court prior to the entry of this order;

d. Instituting legal proceedings or continuing any previous legal proceedings in a Court of Appeals, other than an application for leave to proceed pursuant to R.C. 2323.52(F)(2); and,

e. Any other legal and equitable relief mandated by R.C. 2323.52 and Ohio law to which Plaintiff may be entitled.

3. It is further ordered that the Clerk of Courts shall serve a copy of this Order upon Defendant Terrell Jordan, a.k.a. Tracy Halsell at his last known address.

4. It is further ordered that the Clerk of Courts shall send a certified copy of this order to the Supreme Court of Ohio for publication as provided by law.
