The record reflects that Defendant was duly served with the Complaint and Summons in this action, and that Defendant failed to plead or otherwise defend herself in this action as required by the applicable Ohio Rules of Civil Procedure.

   Kennedy on Count I of Plaintiff's Complaint.
- 2. Defendant Alea R. Kennedy is hereby deemed a vexatious litigator pursuant to R.C. § 2323.52.
- 3. Defendant is hereby indefinitely prohibited from doing any of the following without first obtaining leave of this court to proceed:

a. Instituting legal proceedings in the Court of Claims or in any Court of Common Pleas, Municipal Court, Appellate Court, or County Court in the State of Ohio or its subdivisions;

b. Continuing any legal proceedings that the vexatious litigator had instituted in the Court of Claims or in a Court of Common Pleas, Municipal Court, Appellate Court, or County Court prior to the entry of this order;

c. Making any application, other than an application for leave to proceed under R.C. § 2323.52(F), in any legal proceedings instituted by Defendant or another person in the Court of Claims or in a Court of Common Pleas, Municipal Court, Appellate Court, or County Court.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Clerk of Courts is hereby ordered and directed to serve certified copies of this order on the Supreme Court of Ohio for publication pursuant to R.C. § 2323.52(H) and the parties to this action. Court costs assessed to Defendant.

IT IS SO ORDERED.
