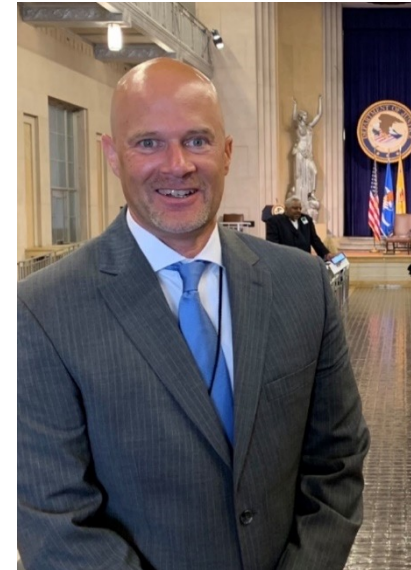

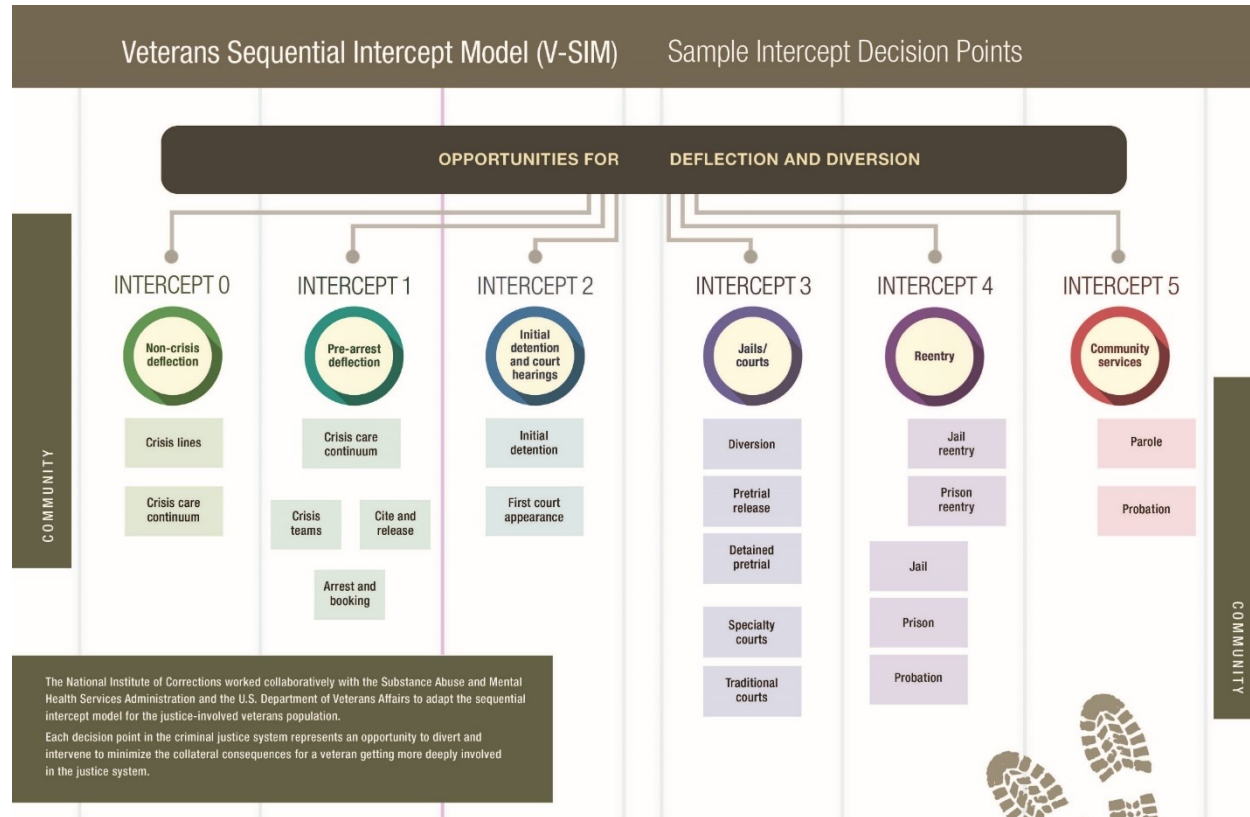
We are a network of community, local, state, and federal partners that identifies and develops innovative and holistic approaches to assist justice-involved veterans.

Veterans Sequential Intercept Model (V-SIM)

The National Institute of Corrections worked collaboratively with SAMSHA, the VA, and members of the Justice Involved Veterans Network to adapt the sequential intercept model to the justice-involved veteran population.



V-SIM Brief Overview

Intercept 0 – Connect People to Services PRIOR to Law Enforcement/CJ

Intercept 1 – Law Enforcement and Emergency Services

Intercept 2 – Initial Detention and Court Hearings (Early ID of Vet Status)

Intercept 3 – Jails/Courts and Opportunities for Clinical Services and Supervision

Intercept 4 – Reentry and Preparing for Reentry with Responsive Services

Intercept 5 – Community Services and Identifying/Addressing Veterans Needs

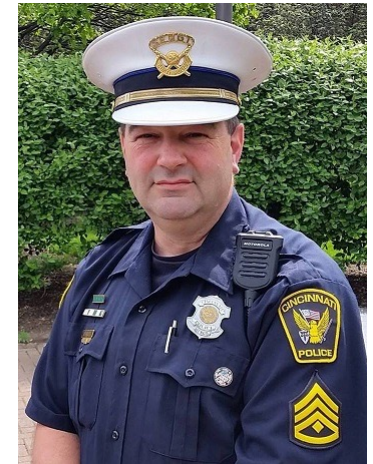

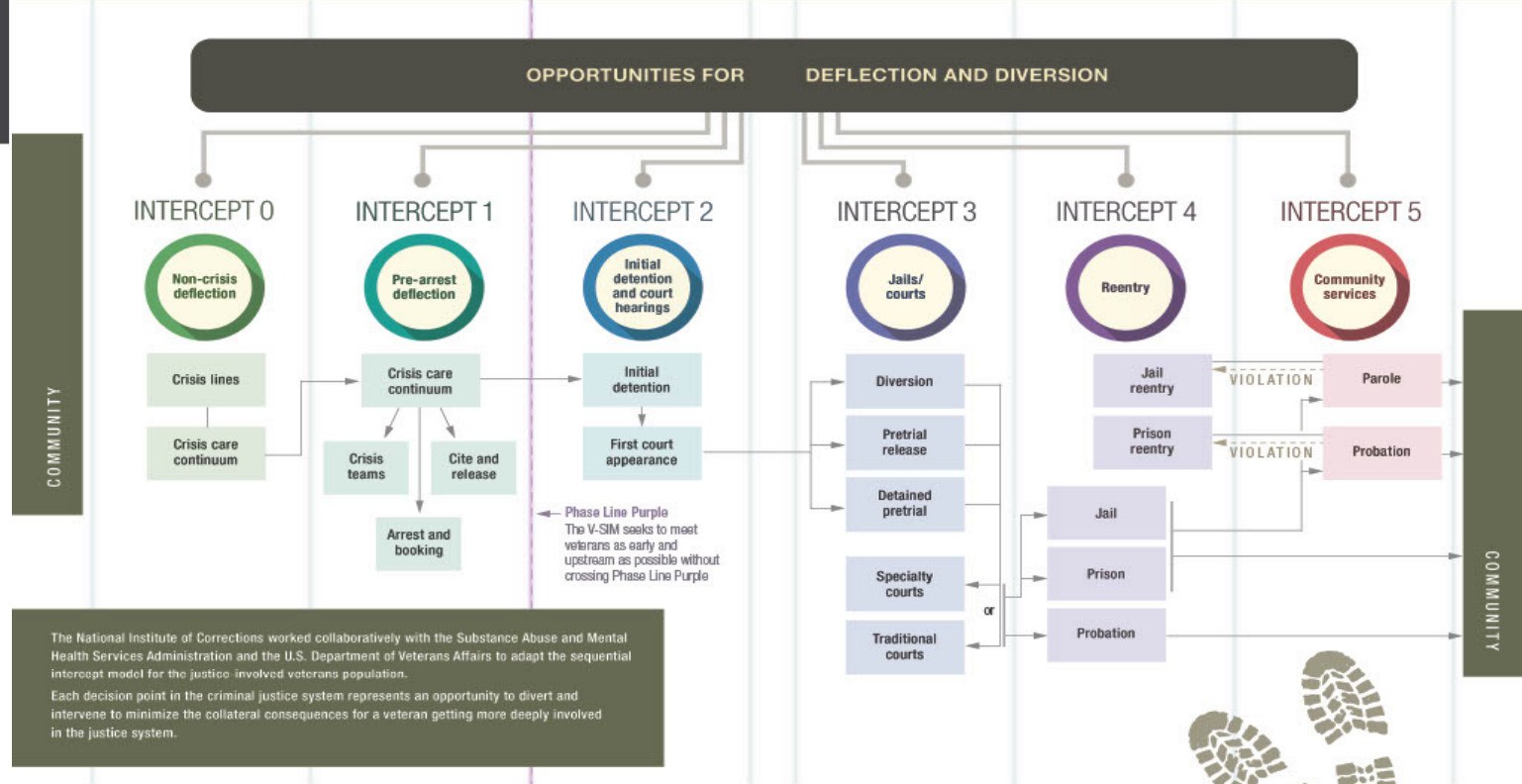

Sample Intercept Decision Points

The Veterans Sequential Intercept Model: Intercepts 0-1



V-SIM at Int 0 and 1

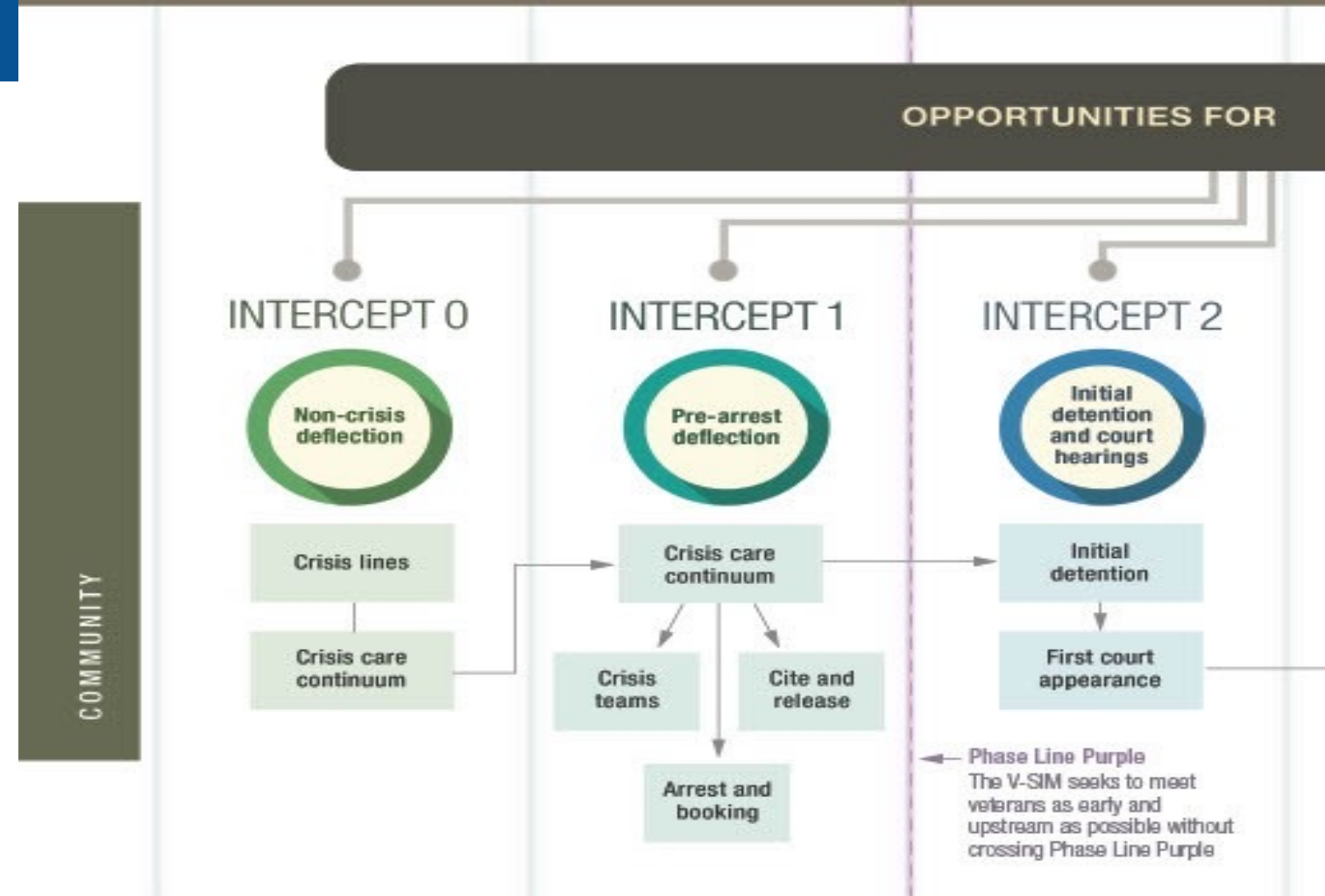
Increased emphasis on community, local LE, and VA collaboration

Focus on Deflection and not just crisis – not waiting for an arrest, crisis, overdose, or arrest to act

Introduction of Veterans Deflection, which is V-SIM 0 and 1 combined

Phase Line Purple - “seeks to meet veterans as early and upstream as possible without crossing Phase Line purple”

Veterans Deflection: Something New Going On!

Meeting Veterans Where They Are Without Waiting for Nor Needing...

- ❖ A Crisis
 - ❖ An Overdose
 - ❖ An Arrest
 - ❖ A Situation
 - ❖ An Event
- ❖ Deflection is an early, upstream strategy
 - ❖ Deflection is prevention
 - ❖ Deflection is leaning forward
 - ❖ TASC and Veterans and Justice

Whatever It's Called: **Third Way for Police (& First Responders)**

1) Arrest 2) Take No Action 3) **Deflect**



How Deflection (Int 0-1) Differs from Diversion (Int 2-5) Meeting Our Veterans Earlier than Ever Before

Deflection (Intercepts 0 -1)

- **Centered in the community**
- Moving *away* from justice system **without having entered it**
- **Behavioral health guided** with criminal justice partnerships
- **No arrest record** and so no collateral consequences

Criminal Justice Diversion (Intercepts 2-5)

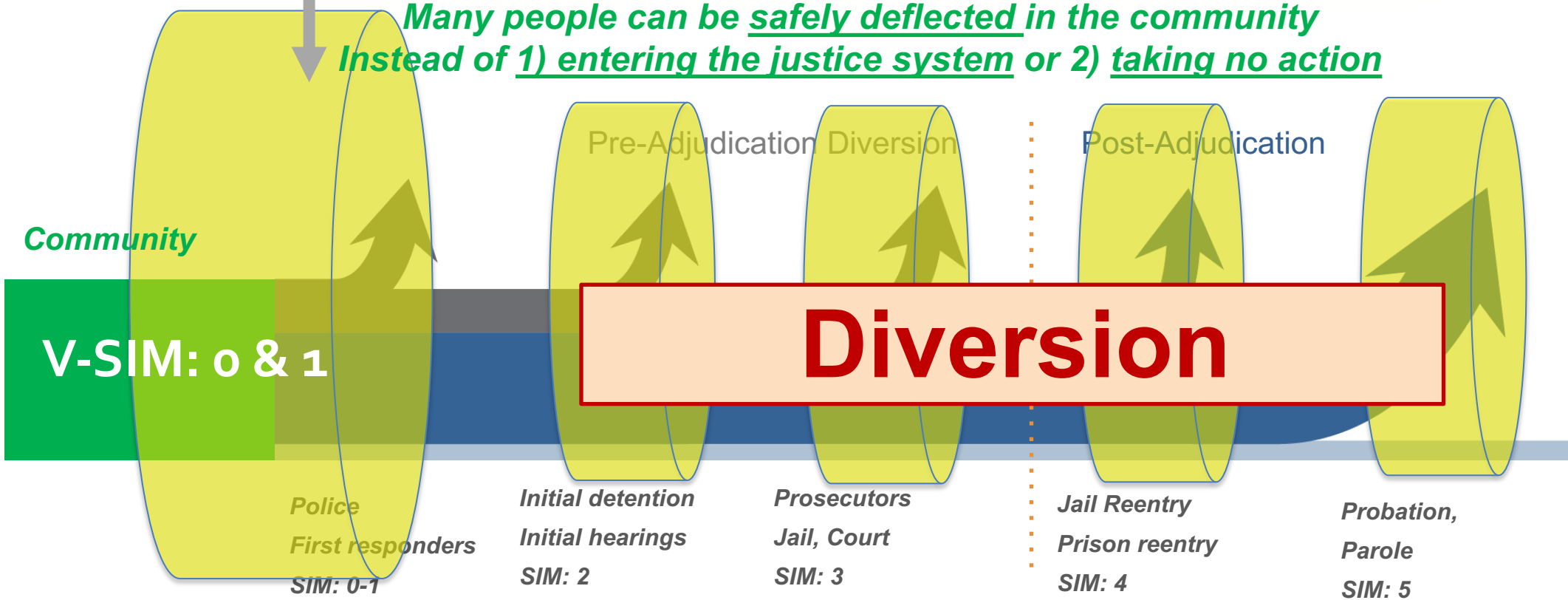
- **Centered in the justice system**
- Moving *out* of justice system **after having entered it**
- **Criminal justice guided** with behavioral health partnerships
- **Arrest record** and related collateral consequences



Deflection Leverages First Responder Contacts for New Opportunities Not Previously Available

Community-based services, housing, and recovery support

Many people can be safely deflected in the community instead of 1) entering the justice system or 2) taking no action



Dos and Don'ts of V-SIM 0-1

Use V-SIM 0-1 Intercepts to...

- Meet veterans as early as possible, where they are, go to them
- Keep veterans in community
- Reduce unnecessary law enforcement and justice contact, and system entry
- Focus on engagement
- Use community resources as solutions

Avoid Using V-SIM 0-1 Intercepts to...

- Enter veterans into the justice system to receive help and treatment
- Build (police) crisis responses as your main veteran response
- Create justice solutions over community solutions
- Wait for a crisis to act

*****Harm to a veteran can arise from an incorrect understanding and improper application of the SIM/V-SIM*****

The Suffolk County Veterans **Traffic** Court exists to identify at-risk veterans and prevent a spiral of criminal involvement.



Intercept 0 – Something Yet to Work On

As a special application to veterans, Intercept 0 contemplates the use of civilian resources to supplement active-duty services to deflect military offenders from military discharges that can *limit their future eligibility for benefits.*



Intercept 1 – Pre-Arrest Deflection

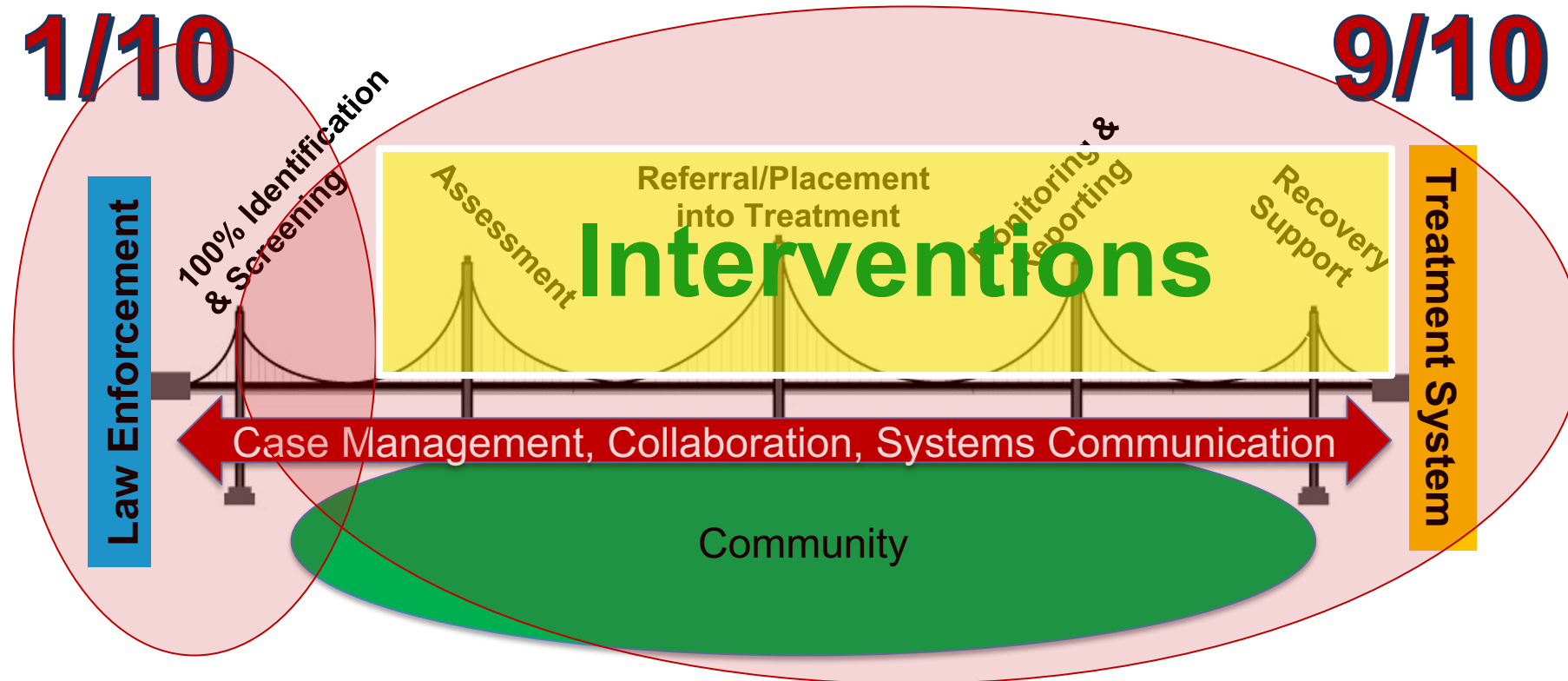

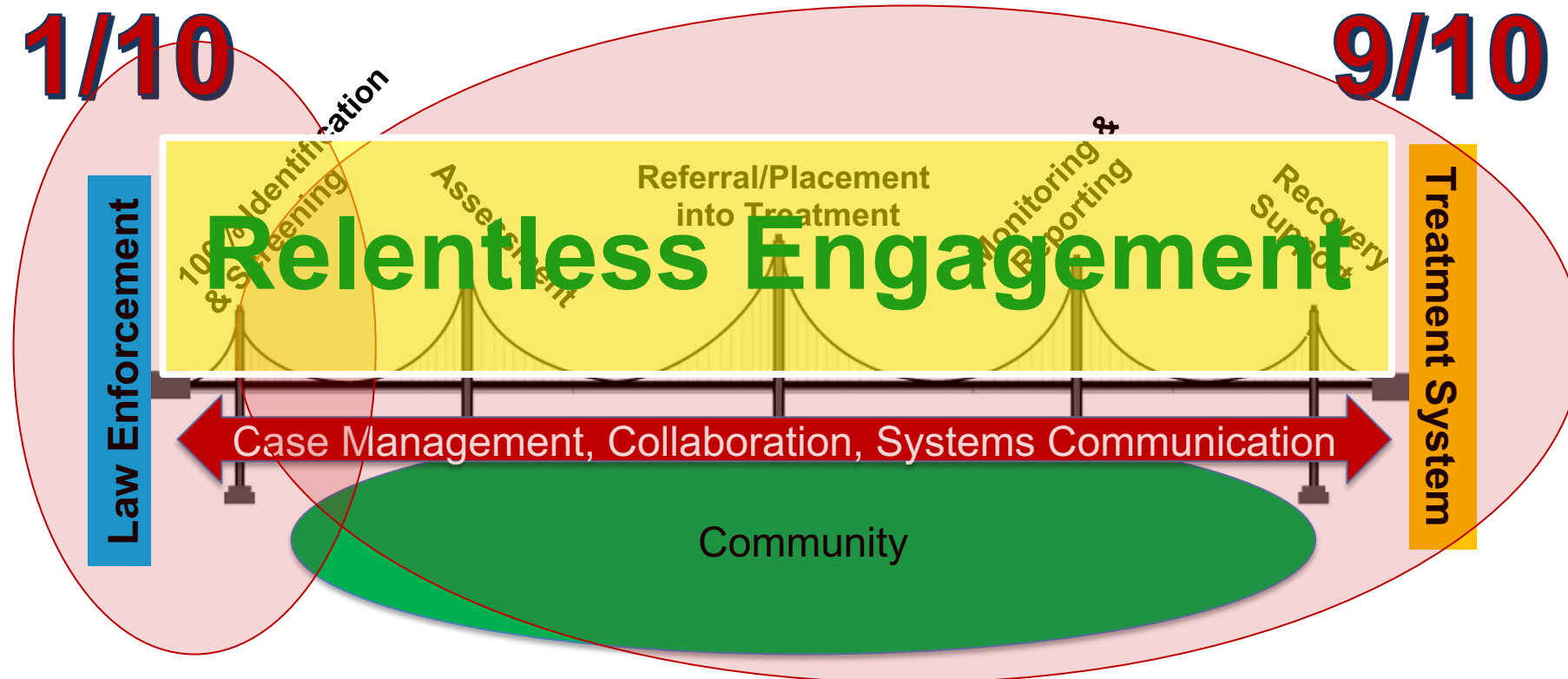

I hope this email finds you safe and healthy in our current national situation. SUNDAY May 3rd marked the 2 year anniversary of the lowest point in my life.

I'm not real sure if you remember that night, but I won't forget it . I locked my self in a factory by the training academy and was gonna take my life. Its the time of year that I wanted to reach out and again say thanks. Words can't express how thankful I am that you were able to get thru to me.

Two years after I'm thriving. Its been 735 days since I've spoken to my son but we are in reunification therapy. So I'm hopeful it will be soon. I am off of probation on June 13th, and am moving from being seen in Veterans Court to being a mentor. I got remarried Febuary 12. And my wife and I are expecting a son in October..... none of this would have been possible without you and I am forever grateful.
