2020-1503. State v. Towns.

Williams App. No. WM-19-023, 2020-Ohio-5120. On amended motion of amicus curiae Ohio Attorney General Dave Yost for oral-argument time. Motion granted. Amicus curiae Ohio Attorney General Dave Yost granted five additional minutes of oral-argument time to be argued after appellee's 15 minutes. Appellant also granted an additional five minutes of oral-argument time for a total of 20 minutes of oral-argument time.

Board of Tax Appeals, No. 2015-263. On appellant's motion for oral argument. Motion granted.
