# 2023-0244. State ex rel. Black v. E. Cleveland, Slip Opinion No. 2024-Ohio-2688.

In Mandamus. Writ granted.

## **2023-0539.** State v. Macklin, Slip Opinion No. **2024-Ohio-2687.**

Cuyahoga App. No. 111117, 2022-Ohio-4400. Judgment reversed on the authority of *State v. Williams*, 2024-Ohio-1433, and *State v. Taylor*, 2024-Ohio-1752, and cause remanded.

## 2023-0829. State ex rel. Curtis v. Turner, Slip Opinion No. 2024-Ohio-2682.

Cuyahoga App. No. 111879, 2023-Ohio-1814. On appellant's motion for judicial notice. Motion denied. Appellee's motion to strike new evidence in appellant's reply brief granted in part and denied in part. Judgment affirmed.
