Fischer, Stewart, and Brunner, JJ., dissent and would grant the motion to dismiss.

Relator's motion to compel respondent to submit unredacted copies of the requested records for in camera review denied.

Stewart, J., dissents in part and would deny the motion for judgment on the pleadings in its entirety and issue an alternative writ as to all the requests.
