2023-0190. State ex rel. Wells v. Lakota Local Schools Bd. of Edn., Slip Opinion No. 2024-Ohio-3316.

In Mandamus. On relator's motion for oral argument or leave to file supplemental brief. Motion denied. Writ granted in part and denied as moot in part. Relator awarded \$2,000 in statutory damages, attorney fees as to the demand letter subject to the filing of an itemized fee application, and court costs. Attorney fees as to the legal invoices denied. Relator shall file an application for attorney fees within 20 days.
