2023-0839. State v. Mays, Slip Opinion No. 2024-Ohio-4616.

Lucas App. No. L-21-1228, **2023-Ohio-1908**. Judgment affirmed.

Kennedy, C.J., and Fischer, DeWine, and Deters, JJ., concur.

Brunner, J., dissents, with an opinion joined by Donnelly and Stewart, JJ.

2023-1105. State ex rel. Howson v. Edmonson, Slip Opinion No. 2024-Ohio-4619.

In Mandamus. On relator's motion to deem attachments to the complaint as evidence and motion to strike the letter attached to respondent's merit brief. Motions granted. Writ denied. Relator's requests for statutory damages, court costs, and attorney fees denied.
