In Mandamus. Sua sponte, alternative writ granted. The following schedule is set for the presentation of evidence and filing of briefs pursuant to S.Ct.Prac.R. 12.05: The parties shall file any evidence they intend to present within 20 days of the court's entry, relator shall file a brief within 30 days of the court's entry, respondent shall file a brief within 20 days after the filing of relator's brief, and relator may file a reply brief within 7 days after the filing of respondent's brief. Sua sponte, respondent ordered to file under seal for in camera inspection records withheld from relator on the basis of privilege.

In Prohibition. On intervening respondents' motion for oral argument. Motion granted. Oral argument will be scheduled at a later date.

any evidence they intend to present within 20 days of the court's entry, relators shall file a brief within 30 days of the court's entry, respondent shall file a brief within 20 days after the filing of relators' brief, and relators may file a reply brief within 7 days after the filing of respondent's brief.
