MOTION AND PROCEDURAL RULINGS

2024-0056. Doe v. Columbus.

Delaware App. No. 23CAE040028. On motion of amicus curiae Ohio Attorney General Dave Yost to participate in oral argument. Motion granted. Amicus curiae Ohio Attorney General Dave Yost shall share time allotted to appellants.

2024-0474. State v. Brown.

Henry App. No. 7-23-05, **2024-Ohio-627**. On appellant's motion to supplement the record. Motion granted. Clerk of Henry County Court of Appeals ordered to supplement the record with questions from the jury and the trial court's written responses within ten days.

2024-1313. State ex rel. Brill v. Lorain Cty. Bd. of Elections.

In Mandamus. On respondents' response in opposition to motion for reconsideration. Sua sponte, response in opposition filed on October 29, 2024, stricken as untimely in accordance with S.Ct.Prac.R. 12.08(B).

2024-1420. State ex rel. Clark v. O'Shaughnessy.

In Mandamus and Prohibition. Sua sponte, it is ordered that within 14 days, relator shall submit a written request for issuance of an additional summons at an alternative address or show cause why this case should not be dismissed for failure to perfect service on respondent Elizabeth Farner.

DISCIPLINARY CASES

2024-0493. Disciplinary Counsel v. Tregre.

Sua sponte, Calvin Syvester Tregre Jr., Attorney Registration No. 0073454, last known business address in Cincinnati, Ohio, found in contempt for failure to file an affidavit of compliance on or before September 23, 2024.

MISCELLANEOUS DISMISSALS

2024-1159. State ex rel. 629 Euclid, Ltd. v. Palos.

In Mandamus and Prohibition. On relators' application for dismissal. Application granted. Cause dismissed.

2024-1235. Restivo v. Harris.

Board of Tax Appeals, No. 2023-1083. Appellants have not filed a merit brief, due October 21, 2024, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore have failed to prosecute this cause with the requisite diligence. Cause dismissed.

2024-1357. A.M. v. J.M.

Cuyahoga App. No. 113901. On appellants' application for dismissal. Application granted. Cause dismissed.

MEDIATION MATTERS

2024-0427. State ex rel. Ross v. Reynolds.

In Mandamus. Pursuant to R.C. 2710.06(B)(1), the court has been notified that the parties to this case have reached a settlement. The case is returned to the regular docket under S.Ct.Prac.R. 19.01. Relator shall file either an application for dismissal or a notice of failure of settlement within 60 days. The case will be dismissed for want of prosecution if an application for dismissal or a notice of failure of settlement is not filed within 60 days.

Trumbull App. No. 2016-T-0085, **2024-Ohio-4451**. On appellees and cross-appellants' motion for referral to mediation. The court refers this case to mediation under S.Ct.Prac.R. 19.01. Sua sponte, the court orders that filing deadlines for this case are not stayed, and the filing prohibitions in S.Ct.Prac.R. 19.01(A)(2) and (3) shall not apply unless otherwise ordered by this court.
