MERIT DECISIONS WITH OPINIONS

2023-0216. Corder v. Ohio Edison Co., Slip Opinion No. 2024-Ohio-5432. Harrison App. No. 21 HA 0008, 2022-Ohio-4818. Judgment reversed and cause remanded to the trial court.

DeWine, Donnelly, Stewart, Brunner, and Deters, JJ., concur. Kennedy, C.J., dissents, with an opinion joined by Fischer, J.
