## MERIT DECISIONS WITHOUT OPINIONS

### **2024-1269. State ex rel. Ware v. Turner.**

In Mandamus. Cause dismissed pursuant to S.Ct.Prac.R. 12.04. Relator's motion to proceed to judgment on statutory damages denied as moot.

Kennedy, C.J., dissents for the reasons stated in her separate opinion in *Bibb v. United States Steel*, [2024-Ohio-1923](#).

## MOTION AND PROCEDURAL RULINGS

### **2023-1001. State v. Fips.**

Cuyahoga App. No. 111900, [2023-Ohio-2295](#). Sua sponte, cause no longer held for the decision in 2022-1227, 2022-1229, 2022-1237, and 2022-1238, *State v. Dunlap*, and stay of briefing schedule lifted. The clerk of the court shall issue an order for the transmittal of the record from the Court of Appeals for Cuyahoga County, and the parties shall brief this case in accordance with the Rules of Practice of the Supreme Court of Ohio.

DeWine and Deters, JJ., dissent.

### **2024-1250. State ex rel. Yost v. Columbus City Schools Bd. of Edn.**

In Mandamus. On respondent's motion to dismiss. Motion granted as to paragraph 51(b) of the complaint and denied as to paragraph 51(a) of the complaint. Respondent's motion to join party denied. Sua sponte, respondent ordered to file an answer to the complaint within 14 days of the court's entry. Sua sponte, alternative writ granted as to paragraph 51(a) of the complaint. The

following schedule is set for presentation of evidence and filing of briefs pursuant to S.Ct.Prac.R. 12.05: The parties shall file any evidence they intend to present within 20 days of the court's entry, relator shall file a brief within 30 days of the court's entry, respondent shall file a brief within 20 days after the filing of relator's brief, and relator may file a reply brief within 7 days after the filing of respondent's brief.

**2024-1263. State ex rel. Siebold v. Columbus City Schools Bd. of Edn.**

In Mandamus. On respondent's motion to dismiss. Motion denied. Respondent's motion to join party denied. Sua sponte, respondent ordered to file an answer to the complaint within 14 days of the court's entry. Sua sponte, alternative writ granted. The following schedule is set for presentation of evidence and filing of briefs pursuant to S.Ct.Prac.R. 12.05: The parties shall file any evidence they intend to present within 20 days of the court's entry, relator shall file a brief within 30 days of the court's entry, respondent shall file a brief within 20 days after the filing of relator's brief, and relator may file a reply brief within 7 days after the filing of respondent's brief.
