Lake App. Nos. 2020-L-016 and 2020-L-017, 2024-Ohio-142. Sua sponte, cause no longer held for the decision in 2023-0654, *State v. Glover*, and stay of briefing schedule lifted as to proposition of law No. I only. Proposition of law No. II dismissed as having been improvidently accepted.

Donnelly and Stewart, JJ., dissent and would summarily reverse the court of appeals' judgment as to proposition of law No. I to apply the rationale in *Glover* supported by Justice Stewart's dissenting opinion and Justice Fischer's concurrence, and dissent as to proposition of law No. II for the reasons set forth in Justice Stewart's dissenting opinion.
