MEDIATION MATTERS

2024-0858. State ex rel. Fenstermaker v. Phillips.

In Mandamus. The court returns this case to the regular docket under S.Ct.Prac.R. 19.01. Relator shall file a response to respondent's motion for judgment on the pleadings, if any, within 10 days of the date of this entry. Relator shall file a brief within 30 days of the date of this entry, respondent shall file a brief within 20 days after the filing of relator's brief, and relator may file a reply brief within 7 days after the filing of respondent's brief. The court may dismiss this case or take other action if the parties fail to timely file merit briefs.

The court refers the following cases to mediation under S.Ct.Prac.R. 19.01 and stays all filing deadlines for each case until further order of this court. The court will not issue any decision on the merits in these cases until mediation has concluded.
