# MERIT DECISIONS WITH OPINIONS

## 2024-0709. State ex rel. Robinson v. Clemans, Slip Opinion No. 2025-Ohio-1021.

In Mandamus. Writ denied. Relator's request for statutory damages, motion for the production of redacted evidence, motion to "dismiss" respondent's answer and merit brief, motion to strike respondent's response to motion for the production of redacted evidence, motion for a peremptory writ, and request for a writ of habeas corpus denied.

In Mandamus. On relator's request for admission of records. Request denied. Relator's motion to reopen amended complaint denied.

## 2025-0007. State ex rel. Cook v. MaGee.

In Mandamus. Sua sponte, alternative writ granted. The following schedule is set for the presentation of evidence and filing of briefs pursuant to S.Ct.Prac.R. 12.05: The parties shall file any evidence they intend to present within 20 days of the court's entry, relator shall file a brief within 30 days of the court's entry, respondent shall file a brief within 20 days after the filing of relator's brief, and relator may file a reply brief within 7 days after the filing of respondent's brief.

Fischer, J., dissents and would sua sponte dismiss the cause.

## 2025-0051. State v. Williamson.
