MOTION AND PROCEDURAL RULINGS

2023-0772. State v. Jones.

Hamilton App. No. C-230005. On motion of amicus curiae, Ohio Attorney General Dave Yost, to participate in oral argument. Motion granted. Amicus curiae shall share time allotted to appellant.

2024-0532. State v. Crawl.

Montgomery App. No. 29859, **2024-Ohio-752**. On motion of amicus curiae, Ohio Attorney General Dave Yost, to participate in oral argument. Motion granted. Amicus curiae shall share time allotted to appellee.

2024-1556. State ex rel. Rankey v. Schiffel.

In Mandamus. On joint motion to stay all deadlines. Motion granted. All deadlines stayed for three weeks.

2025-0057. State v. Price.

Cuyahoga App. No. 113540, **2024-Ohio-5598**. On appellant's motion for leave to amend memorandum in support of jurisdiction. Motion granted. Appellant's amended memorandum in support of jurisdiction deemed filed as of the date of the court's entry.

2025-0058. State v. Ruffin.

Wood App. No. WD-23-058, **2024-Ohio-5626**. On appellant's motion for leave to file revised memorandum in support of jurisdiction. Motion granted. Appellant's revised memorandum in support of jurisdiction deemed filed as of the date of the court's entry.

2025-0118. In re Stanley.

On certification of default. Cam Ryan Stanley, Attorney Registration No. 0098936, last known business address in Defiance, Ohio, suspended from the practice of law for an interim period.

MISCELLANEOUS DISMISSALS

2024-1700. Holmes v. Public Storage.

Butler App. No. CA**2024-10**-124. Appellant has not filed a memorandum in support of jurisdiction, due January 21, 2025, in compliance with the Rules of Practice of the Supreme Court of Ohio and therefore has failed to prosecute this cause with the requisite diligence. Cause dismissed.

MEDIATION MATTERS

2024-0857. State ex rel. Fenstermaker v. Grogan.

In Mandamus. The court returns this case to the regular docket under S.Ct.Prac.R. 19.01. Respondent shall file a brief within 20 days of the court's entry. Relator may file a reply brief within 7 days after the filing of respondent's brief.

2024-1711. State ex rel. Zimmerman v. Avon Lake.

In Mandamus. The court returns this case to the regular docket under S.Ct.Prac.R. 19.01. Respondents shall file a response to the complaint within 21 days of the court's entry.

2025-0107. State ex rel. ClubCorp Holdings, Inc. v. Ohio Dept. of Commerce, Div. of Unclaimed Funds.

In Mandamus. The court refers this case to mediation under S.Ct.Prac.R. 19.01 and stays all filing deadlines for this case until further order of this court. The court will not issue any decision on the merits of this case until mediation has concluded.
